- (1) Volume billed for in cubic feet (CF) for all fractional usage under a hundred cubic feet (Ccf).
- (2) Billable wastewater volume for Domestic class customers with a 3/4", 1", or 1 1/2" tap (not having a separate meter for irrigation purposes provided by CWS to the property on which the customer account is located) is based on 95% of metered water usage.
- (3) All other customer classes, and for those Domestic class customer which do have a separate meter for irrigation purposes provided by CWS to the property on which the account is located, billable wastewater volume is based on 100% of metered water usage.
- (4) Wastewater charges for non-residential or multi-family accounts are based on 100% of water usage.
- (5) CWS Domestic Class customers who are provided retail water service by St. Johns Water Company are billed for wastewater based on 100% of water volume.
- (6) Single family residences without an irrigation meter will be charged no more than the maximum rate for wastewater service. Maximum charge is based on 18 Ccf of water usage (17.1 Ccf wastewater volume).
